

SCOPE OF APPLICATION

PRICES

All prices are given in EUR. VAT is excluded in the prices. The price for the 4-day-training is EURO 2500. Additional cost for conferencecosts will be maximum 50 Euro per day. Accommodationcosts are booked and paid by each participant.

PAYMENT TERMS

The agreement is binding. A binding agreement subject to these terms on conditions is made as between you as a Client and SteP Education AB when we receive a booking form by this website and/or by e-mail. Invoice for the training fee will be emailed to you last week of July and is due one week prior to training start. Invoice will be issued in € (euro) and addressed to the company on the registration form unless we have agreed otherwise.

When failing to pay an invoice within the prescribed time period, the client shall be bound to pay an interest in the amount of 1 % for each month of delay on the total amount of the invoice, including all taxes. Lacking due settlement, SteP Education or Trivium shall be authorized to suspend all performances and supplies of materials without express notice.
